SPECIAL NOTES

- If you wish to apply for exemptions, it should be done before applying for AAT Sri Lanka Examinations.

 Following documents should be sent along with the Exemption Application:
 - 1) **Certified photocopies** of Certificates/Transcripts
 - 2) Original 'Customer Copy' of the cash deposit slip / Online transaction receipt.
 - 3) Two envelopes (Self-addressed and Rs. 15/= stamped)
 - 4) A copy of National Identity Card.
- If you have obtained any exemption previously, attach the original "Exemption Certificate" to the
 application when you are applying for subsequent exemptions.
- Only registered students with active studentship can apply for exemptions.
- Exemption application should be **handed over or sent under registered cover** immediately after the registration but **prior to the Exemption Closing Dates** for each Examination.
- Attestation of your certificates as TRUE COPIES can be done by a Justice of Peace / Chartered Accountant /
 Member of AAT Sri Lanka/ Public Service Officer/ an Accountant of a Government or Commercial Office/ Director
 / Manager / Provincial Officer etc. He/She should mention the Name, Address, Position & Date and place the
 valid seal without fail.
- Exemption Certificate will be **posted within 3 weeks from the date of submission** of the exemption application under normal circumstances **provided all the documents including payment are in order.**
- Submit photocopies of AAT result sheet/s if you have passed/completed subjects/levels.

Please mention **"Exemption Application" on the top left hand corner of the envelope** which is used to send the application, without fail.

Please note that incomplete applications will be rejected without prior notice.
