SPECIAL NOTES

- If you wish to apply for exemptions, **it should be done before applying for AAT Sri Lanka Examinations.**
Following documents should be sent along **with the Exemption Application:**
 - Certified photocopies/clear photos of original** Certificates/Transcripts
 - Original 'Customer Copy' of the cash deposit slip / Online transaction receipt.**
 - One envelope (Self-addressed and Rs. 70/- stamped)
 - A copy of **National Identity Card.**
 - Copy of **AAT result sheet's** if any exam has been done.
- If you have not received the exemption certificate** by the time you receive the exam entry form, please attach a letter stating that you've already applied for exemptions provided that you have not been communicated on any shortcomings associated with your exemption application.
- If you have obtained any exemption previously,** send the **original "Exemption Certificate"** to AAT Sri Lanka Head office under registered cover to below address when you are applying for subsequent exemptions. If you have not received the original exemption certificate yet, please inform us in writing.
- Only registered students **with active studentship** can apply for exemptions. (should be valid for the current year)
- Exemption application should be **handed over or sent under registered cover** immediately after the registration but **prior to the Exemption Closing Dates** for each Examination.
- Attestation of your certificates as TRUE COPIES** can be done by a Justice of Peace / Chartered Accountant / Member of AAT Sri Lanka/Public Service Officer/ an Accountant of a Government or Commercial Office / Director / Manager / Provincial Officer etc. He/She should mention the Name, Address, Position & Date and place the **valid seal without fail.**
- Exemption Certificate will be **posted within 3 weeks from the date of submission** of the exemption application under normal circumstances **provided that all the documents including payment are in order.**
- If you don't receive any update from AAT on your exemptions within 3 weeks after submitting the exemption application, please check with AAT by sending an email to exemption@aatsl.lk.**

Please mention "**Exemption Application**" on the top left hand corner of the envelope which is used to send the application, without fail.
